



**AMENDMENT NUMBER 1
To
Agreement For Services**

This is Amendment Number 1 ("Amendment 1") to the Agreement for Services and Exhibit A – Quote, Quote Number: 1545132000263542190 with a last dated signature of April 25, 2024 ("Agreement") by and between Locality Media, Inc dba First Due ("Locality Media") and City of Lawrence Fire Department ("Customer"). This Amendment 1 shall be effective on the last dated signature below ("Effective Date").

WHEREAS, the Customer wishes to revise the included modules in the Agreement for Services, Exhibit A – Quote, Quote Number: 1545132000263542190 to discontinue use of the Training Records module effective April 30, 2025; and

NOW, THEREFORE, the parties agree as follows:

1. **Whereas Clauses.** The whereas clauses set forth above are incorporated herein by this reference.
2. **Products Change.** Effective April 30, 2025, the Products Detail chart in the Agreement's Exhibit A - Quote, Quote Number: 1545132000263542190 shall be deleted and replaced with:

Product Details
Occupancy Management & Pre-Incident Planning Manage Occupancies, Pre-Incident Mapping, ArcGIS Maps, Fire Systems, Hazardous Material, and Contacts.
Responder Web Responder dashboard and Responder iOS/Android App with notifications, statusing and routing.
Hydrant Management – Basic Manage Hydrants including hydrants visible on pre-plan & response map, hydrant list, hydrant types, hydrant uploads, ArcGIS hydrant layers, and hydrant setup
Inspections Field Inspections, Configurable Checklists, Violation Management, Virtual Inspections, Inspections Scheduler, and Integrated Pre-Incident Planning.
Scheduling Manage staff schedules with an interactive shift board, configurable call shifts module, messaging, time-off and shift trades.
Personnel Management Store, Manage and Access Employee Records including demographic data, certifications and employment information.
Events & Activities Create Events, View Global Activity Log, and Access Global Calendar.

3. **Existing Modules Renewal Fee Revision.** Effective April 30, 2025, the renewal subscription fee for the Existing Modules (Occupancy Management & Pre-Incident Planning, Responder, Hydrant Management – Basic, Inspections, Scheduling, Personnel Management, Events & Activities, Assets & Inventory, First Arriving Integration, and CAD Integration) is revised from \$ 29,872.50 to \$ 27,772.50.

4. **Included First Due modules.** For clarity, after this Amendment 1 is fully executed the Customer will have the following modules contracted on their account:
 - Occupancy Management & Pre-Incident Planning
 - Responder
 - Hydrant Management – Basic
 - Inspections
 - Scheduling
 - Personnel Management
 - Events & Activities
 - Assets & Inventory
 - First Arriving Integration
 - CAD Integration

5. **Amended Records:** After this Amendment 1 is fully executed, Locality Media will revise its records and Customer's invoicing accordingly.

All other terms and conditions in the Agreement remain unchanged.
