#### ADDENDUM TO SERVICES AGREEMENT

### PART I SERVICES BY CLARK DIETZ

#### A. Amendment Description

This Amendment to this project, as originally described in the Professional Services Agreement dated 6/28/2022, is for additional work to the project due to changes in alignment, additional manholes found, and schedule delays involving coordination with IDNR. This project was scheduled to bid in October but delays coordinating with IDNR backed up the schedule added several months of coordination and project management. The route of the sewer was also extended on the downstream end to additional replace the sewer under the creek by LS 403 which required additional utility locates, survey, and coordination. Finally, a couple manholes were discovered from old Fort Harrison record drawings late in the design which required additional coordination and updates to the plans.

### B. Scope

The scope of work for this amendment includes:

- 1. Alignment Extension: The sewer alignment has been extended further downstream to ensure the replacement of the sewer under the creek near Lift Station 403 to avoid future repair needs. This extension requires additional planning, coordination, and design adjustments to accommodate the new path of the sewer line.
  - a. Topographical Survey: A comprehensive topographical survey is required to capture the ground conditions along the extended sewer route. This includes mapping elevation changes, surface features, and any other relevant geographic data to inform the revised design.
  - b. Utility Locates: Due to the alignment extension, further utility locating efforts are necessary by a locating company (Samco). This involves identifying and marking existing underground utilities in the area of interest to prevent conflicts during construction.
- 2. Additional Staking: Extra staking services are required to establish precise construction reference points for the extended alignment and newly discovered manholes. IDNR staff pulled the stakes which required retaking and additional surveyor visits.
- 3. IDNR construction plans with additional annotations and notes created for coordination with IDNR.
- 4. Additional Manholes Discovered Buried: Several previously unknown or forgotten buried manholes were identified by the design team utilizing historical Fort Harrison record drawings late in the design phase. This discovery necessitates additional efforts to update the drawings and project manual.
- 5. Project Management and Administration: Additional project management and administrative efforts are required due to schedule delays and extended coordination with the Indiana

Department of Natural Resources (IDNR). This includes time spent on project meetings, design revisions, documentation, and coordination efforts to ensure all parties remain informed and aligned with the updated project timeline.

- 6. Include fees for Marion County Soil and Water Conservation district IDEM General Construction Stormwater Permit. (\$1,175)
- 7. Prepare legal description and exhibit for easement in Fort Benjimin Harrison Park.

#### C. Schedule

Work for this amendment shall be completed by December 31st, 2025.

### D. Assumptions/Conditions

This Amendment is subject to the following assumptions/conditions:

- 1. Assumes missing manholes will be added to plans approximately and contractor will determine exact locations in the field during the construction phase.
- 2. Work assumes bidding, finishing design and bidding in Q1 2025.
- 3. Bidding and construction services remain unchanged from the original contract.

## PART III COMPENSATION

#### A. Compensation

- 1. Total compensation to Clark Dietz for services rendered on the Project in accordance with PART I, SERVICES of this Amendment will be a lump sum amount of \$61,000. This lump sum compensation includes salaries, payroll taxes and insurance, employee fringe benefits, general overhead costs, profit, and project related expenses. This Amendment increases the total compensation authorized to \$410,260.
- 2. Inspection Services Compensation to Clark Dietz for services rendered by employees working on the Project in accordance with PART I SERVICES BY CLARK DIETZ of this Agreement will be at the hourly billing rates shown in the attachment, "Schedule of General Billing Rates". The total compensation authorized by this Agreement will not exceed \$132,730 (and is unchanged by this amendment), and shall include the following:
  - a. Payment for outside consulting and/or professional services performed by a subconsultant will be at actual invoice cost to Clark Dietz. Clark Dietz will obtain written Client approval before authorizing these services.
  - b. Payment for expenses incurred directly on behalf of the Project at actual cost to Clark Dietz plus ten percent for administrative costs. Direct project expenses will be as defined in the attachment, "Schedule of Project Related Expenses".
