

October 8, 2024 - Superintendent's Report

ADMIN UPDATE:

The Utility is seeking approval of the Addendum to Services Agreement with Culy Contracting, LLC for the necessary work and materials to perform the emergency sanitary sewer force main repair.

As you were all aware as I updated the Board on the status of the emergency repair, there was a significant amount of time that passed as we awaited approval from CSX to begin the necessary work. The additional time resulted in additional charges for the traffic control measures that had to remain on site in Pendleton Pike (arrow boards, barrels, steel plates over excavation in Pendleton Pike) as well as the backhoe that had to be left on site to move the steel plates to check to make sure the "temporary" repair was still in place and had not failed. Due to the availability of the CSX inspector that had to be present while work was performed under the railroad tracks, work had to be scheduled on a Saturday which resulted in additional charges for overtime pay to the repair contractor.

The original quote received for the repair/replacement was for \$124,881.13. The additional charges for Culy Contracting to complete the work and to pay the CSX inspector are \$125,154.62, bringing the total for the repair work to \$250,035.75.

The Utility is seeking approval of a Sanitary Sewer General Construction Observation Agreement between KG Fort, LLC for inspections services for work performed at 5611 Lawrence Village Parkway. Lawrence Utilities will bill the owner for an estimated fee of \$1,800.00 (\$75.00/hr.)

The Utility is seeking approval of a Water Line General Construction Observation Agreement between KG Fort, LLC for inspections services for work performed at 5611 Lawrence Village Parkway. Lawrence Utilities will bill the owner for an estimated fee of \$750.00.00 (\$75.00/hr.)
