## March 11, 2025 - Superintendent's Report

The Utility is seeking approval of Resolution No. 2, 2025 declaring certain property to be surplus and authorizing disposal. We recommend approval.

The Utility has received a response from the Environmental Protection Agency (EPA) regarding the Sanitary Sewer Overflow Corrective Action Plan submitted January 30, 2024, as part of the Administrative Order on Consent. Issued November of 2021. The response contained five questions asking for additional information/clarification about items mentioned in the Corrective Action Plan. American Structurepoint and Powers Engineering are working on the response so it can be sent to the EPA within the 30-day period requested.

On March 13 and 20, 2025 the advertisements for Requests for Bids will run in the Indy Star for the Lawrence 71<sup>st</sup> Street Lift Station Basin Rehabilitation Project 2024.01440 (Inflow & Infiltration Reduction Project). We will keep the board updated as the project moves forward.
