# Lawrence Police Department Citizen Academy

#### **Concept:**

The Lawrence Police Department's Citizen Academy is a contemporary concept in Law Enforcement-Community relations. The Lawrence Police Department Citizen Academy serves as a part of a continuing program to develop citizen awareness and understanding of the role of local law enforcement. It is important to understand that the Citizens Academy is **NOT** a "citizens on patrol" project, and participants receive absolutely **NO** special police powers, authority, or responsibility.

#### **Challenge:**

Our continuing challenge is to develop strategies that will increase the understanding of the role law enforcement plays in our community, and of the citizens we serve. The results will benefit our Department's effectiveness in assisting with problems. The Lawrence Police Department Citizen Academy functions as an added resource to the community to increase this understanding.

#### Goals:

In our continuing efforts to develop community awareness through education, the Lawrence Police Department Citizen Academy will produce better informed citizens with a deeper understanding of the Lawrence Police Department and the role law enforcement plays in the community. The Lawrence Police Department Citizen Academy will promote the concept of *Together Everyone Achieves More*. This will create better teamwork and cooperation between the Lawrence Police Department and the citizens we serve.

## **Program:**

The Lawrence Police Department Citizen Academy is an 11-week program. The program consists of weekly 3-hour classes that include lectures, hands-on learning and role-playing scenarios. Citizens will be *required* to complete a ride-along with a patrol officer. This program will provide an overview of the professional training that Lawrence Police Department officers receive and how we function to provide the highest level of service and protection to the community. Participants must be at least 21 years old prior to the start of the Citizens Academy.

#### Focus:

Graduates of the Lawrence Police Department Citizen Academy will gain an improved understanding of the Lawrence Police Department's policing function and will be able to better assist officers in identifying and resolving problems in their community. This will improve the efficiency of the Lawrence Police Department and raise the quality of life enjoyed by citizens of the community.
